In consideration of acceptance of the terms of this contract, Concordia Preparatory School agrees to reserve a space for the above named student for the 2021-2022 academic year on a Concordia Preparatory School bus from Harford Mall, 696 Belair Road, Bel Air, MD 21014, stopping at St. Paul's Lutheran Church and School, 12022 Jerusalem Rd, Kingsville, MD 21087 continuing to Concordia Preparatory School, 1145 Concordia Drive Towson, Maryland 21286.

My child will be using the (check one):

- Harford Mall Location (696 Belair Road, Bel Air, MD 21014—parking lot on the side of Sears)
- St. Paul's Lutheran Church and School (12022 Jerusalem Rd, Kingsville, MD 21014)

The terms of this contract are:

Bus service begins on Wednesday, August 25, 2021. The bus will leave Harford Mall at 6:40 a.m and stop at St. Paul's Lutheran Church and School. It will depart St. Paul's at 7:00 am. The bus will depart Concordia Preparatory School after school at 3:30 p.m. Monday-Friday.

I understand that my obligation to pay the transportation fee in full (\$1,068.75) or a monthly fee of \$125.00 per month (September 2021 through May 2022) is unconditional. No portion of the fee paid will be refunded, and I will be responsible for any outstanding balance. Please check your preferred payment method:

- I will pay for all nine months before August 26, 2021. If I pay prior to August 26, 2021, I will receive a 5% discount (\$45.00).
- I will pay through FACTS Tuition Management monthly.

Any unpaid bus service fees may result in your child not being permitted to ride the bus. I understand that only paid riders are permitted to use the bus; no guests are allowed to ride.

The bus service will not operate on days that Concordia Preparatory School is scheduled to be closed as posted on the 2021-2022 school calendar or is closed for inclement weather or for other school cancellations as posted by the school.

If Concordia Preparatory School is closed on a scheduled school day because of inclement weather or other reasons, there will be no bus service. In the event of delayed openings due to weather, the bus service will operate as indicated below:

Inclement Weather Information:

- One-hour delay means the bus will depart at 7:45 a.m.
- Two-hour delay means that the bus depart at 8:45 a.m.

I understand that in signing this contract for the 2021-2022 academic year. I am agreeing to accept the rules and regulations as stated in current handbooks and the rules concerning payment of fees as stated above.

I understand that misbehavior will not be tolerated. Riders are to follow the rules stipulated by Concordia Preparatory school's handbook. Riders are not to engage other students in negative, hostile or inappropriate ways. Teasing and bullying will not be tolerated. **Riders may carry cell phones with them but those phones are to be used only to communicate with their parents or listen to music with headphones. Students are not permitted to take or share photos, videos or recordings of any type while on the bus.** Failure to follow the rules of the bus will end in suspension from the bus service.

I hereby release, waive, discharge and covenant not to sue Concordia Preparatory School, their officers, agents, servants or employees from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage or injury, including death, that may be sustained by student or any of the property belonging to student while participating in the bus service, including, but not limited to, waiting for the bus off of Concordia Preparatory School premises.

In order to insure a place for my son/daughter on the Harford County bus for the 2021-2022 academic year, I hereby submit one (1) signed copy of this Agreement. Please keep a copy for your records.

I HAVE CAREFULLY READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS AND CONDITIONS WITHOUT RESERVATION, HAVE HAD AMPLE OPPORTUNITY TO CONSULT WITH LEGAL COUNSEL OF MY CHOICE, AND SIGN IT AS MY VOLUNTARY ACT.
